Paper Guidelines

13 August 2026

1. Conditions

- The deadline for submitting papers is 31 May 2027. Failure to submit the paper by the deadline may result in the cancellation of the applicant's participation.
- Papers should be a complete version of the work and in line with the workshop description and the approved paper proposal.
- Papers should meet, as much as possible, the criteria in terms of length, structure, and format as listed below.
- Papers will be amended before and after the workshop, to include the feedback gathered from the directors, discussant, and other participants.
- Authors who submitted their paper by the 31 May 2027 deadline may be asked in June 2027 to revise and resubmit their paper within approx. 1 week and in any case not later than 22 June.
- Authors will be given a deadline of 20 September 2027 to finalise their paper for publication (workshop directors may give a slightly deadline) taking into account the feedback received during and after the workshop.
- Papers should be uploaded to the GRM Online System. In case the uploading is not successful, please contact grm@grc.net. Revised and final papers should be uploaded as well, automatically replacing previous versions.
- Submission of the paper signifies that the participant agrees, once again (participants have already agreed to them by confirming their participation), to the GRCC Intellectual Property Guidelines.
- Authors will be informed about the suggested destination of their paper, in a joint publication or as an individual paper, by the workshop directors and GRC by 30 September 2027.

2. Paper Length, Structure, Format, Use of AI

- Deadline: 31 May 2027
- Submission: Uploading onto the GRM website

- Focus: Follows the workshop description and the abstract that was accepted
- Language: English - should be submitted in (almost) perfect English
- Paper length: 6,500-10,000 words (including tables, graphs, footnotes, and references)
- Paper abstract: 250-300 words
- Biographical note author: 250 words
- Photo author: Passport size
- Software: MS Word
- Page format: A4
- Margins: 2.5 cm top, bottom, left, right
- Line spacing: 1.5
- Font: Times New Roman 12-point for text; 11 for citations; 10 for footnotes
- Sections: Main headlines, section headlines, and sub-section headlines should be clearly indicated by different font sizes and where necessary, italics
- Graphs/tables: Can be included in the text or can be grouped at the end of the paper (in the latter case it should be indicated where they are to be placed in the text)
- Footnotes/bibliography: Chicago Manual of Style, i.e., in the text use surname of author and year and provide a full bibliography at the end of the text
- Headers/footers: None
- Page numbering: Centre at bottom
- Pictures: None
- Alignment: Justified (left and right)
- Keywords: Please choose keywords that are the most appropriate to describe the paper.
- Plagiarism. Plagiarism is not acceptable in any form.
- Use of AI: We recognize that AI tools can be useful in supporting academic work. However, their use must remain limited, transparent, and fully aligned with established academic standards. Thus:
 - AI tools may be used only for assistance purposes, such as language editing, clarity, or formatting. They must not be used for conceptualization, argument development, original analysis, or the generation of substantive academic content.
 - As one of the primary objectives of the GRM is the publication of papers in reputable academic journals and edited volumes, keep in mind that these outlets apply strict policies and rigorous checks regarding AI-generated content.
 - The use of AI in GRM papers must not exceed 20% of the total text, including but not limited to quoted material, footnotes, references, and bibliographies.
 - To ensure compliance, the GRCC uses various software tools to assess the extent of AI use in submitted papers and reserves the right to reject or require revision of any paper that exceeds the permitted level of AI use.
- On the top of their papers, authors should write:
 - 17th Gulf Research Meeting, Cambridge (UK), 20-22 July 2027
 - Workshop Number and Title
 - Paper Title
 - Author(s)
 - Affiliation(s) of Author(s)
 - Add: No Citation, Quotation, or Sharing
- When uploading the paper to the GRM portal, please ensure that the file name contains no spaces, no special characters (comma, periods, semicolon, etc.), and is titled with the first

author's name and workshop number (i.e., JohnSmith-WS7).

These are treated essentially as books.

- International bodies

Citations to documents of international bodies such as the UN should identify the authorizing body (and the author where appropriate), the title of the paper, and the date. Series, publication number, and place of publication may be included.
